Subject: Resignation as Statutory Auditors of Suzuki Motor Gujarat Private Limited ("the Company")

We were appointed as statutory auditors of the Company to hold office from the conclusion of the 7th Annual General Meeting held on August 20, 2021, till the conclusion of the 12th Annual General Meeting of the Company i.e., for a period of 5 years commencing from financial year April 01, 2021, to financial year ending March 31, 2026.

We have completed the statutory audit of financial statements of the Company for the year ended March 31, 2025, and have issued our audit report dated April 24, 2025. We have not commenced the statutory audit of the Company as at and for the year ending March 31, 2026.

In the meantime, we have received a letter dated May 07, 2025, from Mr. Tetsuharu Hayasaka, Managing Director who has also had a discussion with us (referred to as "Communication"). We understand from the Communication that the Board of Directors of Suzuki Motor Corporation, the Company's ultimate holding company (the "Ultimate Holding Company") has recently approved a change in their statutory auditor. Pursuant to this, for reasons of the Company's operational efficiency, need for bringing in synergies with the Ultimate Holding Company audit firm, as well as maintaining consistency in the audit process, the Company intends to align with its Ultimate Holding Company and appoint a statutory auditor in India which is part of the same network as that of the Ultimate Holding Company's statutory auditor.

In view of this, we are tendering our resignation as statutory auditors of the Company with immediate effect.

We thank you for the cooperation and courtesies extended to us during our term as statutory auditors of the Company.

Please find attached in Annexure A the information to be obtained by the Company from the auditors of listed entities and their material subsidiaries for the resignation as required by SEBI circular SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024.
