# No detention till Class VIII, no boards for Class XI in TN

## Curriculum To Include Digital, Tech Literacy

**Chennai:** Tamil Nadu govt's State Education Policy (SEP) for school education, unveiled on Friday, has reposed faith in the present system, including two-language formula, no-detention policy up to Class VIII, and board exams only for Class X and XII. It has abolished board examinations for Class XI.

The National Education Policy (NEP) recommends a three-language formula, common exams for Classes III, V, and VIII, and a new school education system of 5+3+3+4.

The policy also mandated a climate curriculum focused on Tamil Nadu's specific environmental challenges for school students. It also recommended introducing financial literacy, digital literacy, and technology skills for school students.

"We will follow a two-language policy with Tamil and



Tamil Nadu chief minister M K Stalin said the policy was aimed at grooming students to think and ask questions rather than merely learn by memorising

English," Chief minister MK Stalin said after releasing the SEP, adding that physical education will be added to the curriculum. "Education for

all, quality education for all is the policy of our Dravidian model govt. This policy will help our students to compete globally," Stalin said.

Abolishing the board exams for Class XI state board students, introduced in 2018, the SEP said: "Class XI should be treated as a preparatory and transition year focusing on subject enrichment, skill development, and academic readiness through

continuous, competency-based internal assessments. This approach will help reduce exam-related stress."

"Curricular content needs to address structures of inequality related to caste, gender, and socio-economic status. Tamil Nadu's rich cultural, historical, and environmental context needs to be showcased," the policy said.

The SEP also advocates activity-based learning, project-based learning, experiential learning, and arts and sports integration. Students will receive structured career guidance from Class IX, and schools need to have solar panels, rainwater harvesting, digital labs, clean sanitation, and inclusive play areas.

Speaking to reporters later, school education minister Anbil Mahesh Poyyamozhi stated that all students studying in state board, CBSE, ICSE, or IB curriculum need to study Tamil as a subject from Class I to X as per the Tamil Nadu Tamil Learning Act, 2006. While opting for the no-detention policy, we will ensure that all students attain the learning level prescribed for each class."

## 6 dead in HP as boulders slam car, drive it into gorge

**Kullu:** Four of a family were among six people killed when boulders slammed into a car and sent it hurtling down a 500m gorge in Himachal Pradesh's Chamba district on Thursday. The dead include a couple and their children.

Police identified the victims as Rajesh Kumar, 40, a govt school teacher, wife Hanso Devi, 35, their children Aarti, 17, and Dipak, 15, and friends Rakesh Kumar, 44, and Hem Pal, 37.

They were returning from Banikhet near Dalhousie when the accident occurred around 9.30pm in Churah subdivision. According to Churah MLA Hans Raj, who visited the spot, several boulders hit the vehicle.

Locals were first on the scene after alerting police and emergency services. A police officer said the rescue operation was very challenging as the spot was inaccessible. Crushed under boulders and having fallen from such a height, all victims died on the spot. **TNN**

**Man stabbed to death:** A 40-year-old man was stabbed to death in broad daylight on Friday over a minor dispute at a tea stall in Anand district, police said. At around 8 am, Rajesh Kumar (40), a resident of Poore Pancham village, had gone to the tea stall where a man named Ram Bahadur stabbed him after a minor dispute, ASP Shailendra Kumar Singh said. **PTI**

## Morbi: 4 charred to death after truck-car collision

Deceased include 2 students in car, 2 occupants of truck

FOUR PERSONS, among them two children, were charred to death in a collision involving two heavy vehicles and a car on a highway in Gujarat's Morbi district, police said on Friday.

The accident occurred on a national highway near Haripur village around 11 pm on Thursday, an official said.

Superintendent of Police Rahul Tripathi said a container entered the road from the wrong

side and overturned, causing a collision between a truck and a car, which caught fire.

"Prima facie, a major fire broke out in a car after it collided with a truck going alongside. The truck also caught fire in the collision. Four people died of burn injuries," he said. The deceased included two students travelling in the car and two occupants of the truck, the official said.

"Students from a boarding school in Junagadh were travelling to their home towns in Kutch district," Tripathi said.

"Seven others suffered minor

injuries and were rescued by the fire department personnel and shifted to a private hospital," an official from the Morbi fire department said.

Rudra Gujarja (15), Jamin Babariya (17), both car passengers, and one Shivram Nai, a resident of Bikaner in Rajasthan, were among the deceased, while the identity of another victim is yet to be ascertained, an official from Maliya Miyana police station said. The bodies were shifted to Rajkot for post-mortem, and a probe was underway, police said.

## Patidar community members from Surat visit Bhavnagar

Condition of victim stable; one accused held, 2 on run: police

A DAY after an elderly person in Kalatalav village of Vallabhipur taluka of Bhavnagar district was allegedly assaulted by three youths belonging to another community from the same village, a group of Patidar community members from Surat visited the village, extending support to the victim. Police said that the condition of Arjanbhai Lidiya, 74, is stable. Lidiya was assaulted by the youth using sticks after a quarrel over the elderly man taking sand from a water canal on the outskirts of Kalatalav village on Thursday, police said.

Vallabhipur police arrested one of the accused, Raju Ulva, on Friday. Police said a hunt has been launched for two other accused — Natha Rabari and Mamaiya Rabari.

Talking to *The Indian Express*, Vallabhipur police inspector HB Chauhan said, "We have registered a case against three accused youths, who are also residents of the same village."

"We have also deployed police in the village to prevent any untoward incidents. Lidiya has been staying with his wife while his sons work in Surat," Chauhan said.

The Patidar community members from Surat made a representation to Range IGP (Inspector General of Police) Gautam Parmar and demanded stern action against the accused.

On Friday morning, they met Lidiya at the hospital. Later in the evening, the Patidar community members, who travelled around

340 km from Surat to Bhavnagar, held a meeting in the village. The meeting was attended by Patidar community members from neighbouring villages also.

Talking to *The Indian Express*, Patidar Sewa Sangh Surat president Vijay Mangukiya said, "A large number of Patidar community members from Saurashtra region are settled in Surat to earn a livelihood, leaving behind their elderly parents in their villages. We urged the Range IGP to take stern action against the accused in such attacks." "In the meeting held in Kalatalav village, a large number of Patidar community members attended. We told them that the Patidar Sewa Sangh is with them."

After a video of the incident went viral, Patidar community leaders had called a meeting in Surat on Thursday night. The meeting was attended by former Patidar Anamat Andolan Samithi leader Alpesh Katheriya, Vijay Mangukiya, Abhi Kalathiya, Surat convenor of Sardar Dham Ashok Adhewal and others. After the meeting, a large number of community leaders left for Bhavnagar.
